### Remote Testing Update

- Remote Testing Continues on a Limited Scale
- Work in partnership with College of Lake County to deliver remote tests on a monthly basis.
- Out-of-State Candidates



# Out-of-State Reciprocity

- In 2024, the project processed and added 2,255 candidates from outside of Illinois that wanted to be added to the IDPH HCW Registry for employment in Illinois.
- This is a 35% decrease from 2023 when there were 3,450 added to the HCW Registry.



# Recertifications

- In 2024, the project processed 5,412 candidates that had been without paid employment for 24 months. Of those, 1,851 (34%) sat for the competency exam.
- A total of 1,617 (87%) candidates completed the recertification process and became active on the HCW Registry.



# Other IDPH Approvals

- In 2024, the project processed 859 Fundamentals of Nursing candidates. Of those 832 were added to the IDPH HCW Registry for employment in Illinois.
- In 2024 the project processed 56 Foreign Trained Nurse Candidates. Of those 39 were added to the IDPH HCW Registry for employment in Illinois



### Annual Exam Results by Program Type




# MEAN SCORE BY PROGRAM TYPE

### Spanish Translation Update

- We have been working with DxR Development Group since August 2024 to modify the INACE testing program to provide the competency exam in English and Spanish.
- ♦ We do have a paper-based version available.





Students are eligible to receive Individualized Education Plan (IEP) accommodations when taking the CNA exam.

 Accommodation documents should be sent to the NAT office as soon as possible, once the training program determines the accommodations that will be granted.

Testers MUST HAVE their login ID and password and should use it to access their account a few days before the test.

 Autosaving this information on the INACE website on their phone contributes to the tester's inability to recall the login ID and password.



♦ Testers MUST HAVE their photo ID to present to the test site staff and should arrive at least 20-30 minutes early.


